PRODUCT INFORMATION

Handiply Carpet Grade Flooring Structural plywood (Handiply Carpet Grade) is a layered panel made from New Zealand pine wood veneers manufactured by Carter Holt Harvey Plywood Limited (CHH Plywood) to the requirements of AS/NZS 2269: Structural Plywood (AS/NZS 2269).

As a downgraded product, Handiply Carpet Grade has a limited range of suitable applications. Handiply Carpet Grade is ideal as a substrate for most carpet and floor coverings where the aesthetics of the surface grade does not matter.

SUGGESTED APPLICATIONS

- Handiply Carpet Grade specified in flooring applications in accordance with Ecoply plywood in the current 'Ecoply Specification & Installation Guide', or subject to specific engineering design, is suitable for use as a flooring substrate for overlays such as carpet and tiles.
- Handiply Carpet Grade, as specified as an alternative to Ecoply Flooring in Section 5 of the current 'Ecoply Specification & Installation Guide' is suitable for use as a

flooring substrate subject to loading and spans conditions detailed in Table 17: Flooring Frame Spacings or subject to specific engineering design.

- Handiply Carpet Grade may be used as a floor diaphragm in bracing applications subject to the requirements of NZS 3604 or specific engineering design and detailing.
- Handiply Carpet Grade Plywood is not suitable for use with membrane floors and decks or where the product is left exposed for a visual application.

INSTALLATION

Handiply Carpet Grade must be competently installed in accordance with good building practice, sound design principles, and the requirements of Section 5.0 of the current 'Ecoply Specification & Installation Guide' or details provided by a Certified Practicing Engineer.

This is the responsibility of building owners and the design professionals and builders that they engage.

SURFACE GRADE

AVAILABILITY

Handiply Carpet Grade is only available as a downgraded product from the manufacture of first grade CD Ecoply Flooring products. Supply of Handiply Carpet Grade therefore cannot be guaranteed and supply is always 'subject to availability.'

EDGE PROFILE

Handiply Carpet Grade is supplied with a tongue and groove on the long sheet edges which does not require blocking under the joint (unless otherwise specified).

GLUE BOND

The veneers are bonded together with synthetic phenolic (PF) resin set and cured under heat and pressure in controlled conditions to form a strong and durable Type A bond.

TREATMENT

Handiply Carpet Grade is available either untreated or H3.2 CCA treated (subject to availability). H3.2 CCA Handiply Carpet Grade is envelope preservative treated. Where sheets are cut, cuts must be coated with a brush on timber preservative. Soudal® Metalex® Clear is recommended. Failure to do so may affect the long term durability of the panel.

The use of untreated Carpet Grade is subject to the requirements of NZS 3602 Timber and Wood Based Products for use in building (NZS 3602), in accordance with New Zealand Building Code (NZBC) Clause B2 Durability. CHH Plywood recommend the use of H3.2 CCA treated flooring below wet areas.

Please note:

- H3.2 CCA treated Carpet Grade must not be installed in direct contact to steel frames.
- H3.2 CCA treatment may leave a green tinge and fillet marks on the sheet surface and treated products.
